#### COMPOSITION COMMENTS

Natural Dry Ball Clay. Ball clay is a kaolinitic sedimentary clay of natural origin. Imerys ball clay products consist primarily of kaolin and quartz with variable proportions of other minerals. A proportion of the quartz may become available in the respirable fraction. The level of exposure to respirable silica will depend on the actions performed on the product during handling and use. Exposure levels should, therefore, be measured during use, in comparison to relevant occupational exposure limits, as exposure cannot be determined from bulk product analysis.

### 3 HAZARDS IDENTIFICATION

Not regarded as a health or environmental hazard under current legislation.

#### PHYSICAL AND CHEMICAL HAZARDS

Wet substance spillage can constitute a slipping hazard.

#### HUMAN HEALTH
